Selectmen's Meeting March 25, 2021

5:30pm the meeting was called to order by Chair, William Flynn.

**Minutes** of March 16<sup>th</sup> were approved by Bill; seconded by Ricky. Vote 3-0-0.

**Ball Fields** – Bill suggested that we have a conversation with the new owner of the Rye Field to discuss property lines. Megan will reach out to invite him to an upcoming Selectmen's meeting.

**Fire Truck Bid Opening** – One sealed bid was received after the deadline of March 16<sup>th</sup> at 4:30pm for the 1988 International, but since it was postmarked March 12<sup>th</sup> the Board agreed to open in. Erik motioned to not accept the bid of \$4,250 from Asian Auto Service in Plaistow, NH because it did not meet the minimum bid requirement of \$8,500; seconded by Ricky. Vote 3-0-0.

**Budget/Warrant** – There was discussion of the proposed Admirative budget that will be presented to the Budget Committee on April 5<sup>th</sup>. Joe Egan asked if there had been thought of a sub committee to research other Maine towns wages and compare them to our town; Erik motioned for Joe to form a sub-committee to consist of several budget committee members to research employee wages; seconded by Ricky. Vote 3-0-0. Ricky asked Megan to find out what LRAF funds were available for paving and what excise tax we have taken in.; Megan will ask Wanda for these numbers. Lori Talman suggested that we advertise more in the Shoppers Guide as some people do not have the internet to check the website; Ricky suggested that we add \$2,000 in advertising expenses to accommodate this. The Shoppers Guide also has a "What's Happening" section where you can advertise 30 words or less for free.

**RHR Smith** – The Board asked if Ron had sent over the information for the statutory requirements for the Treasurer; Megan stated that she has not received anything yet but will reach out to him tomorrow.
