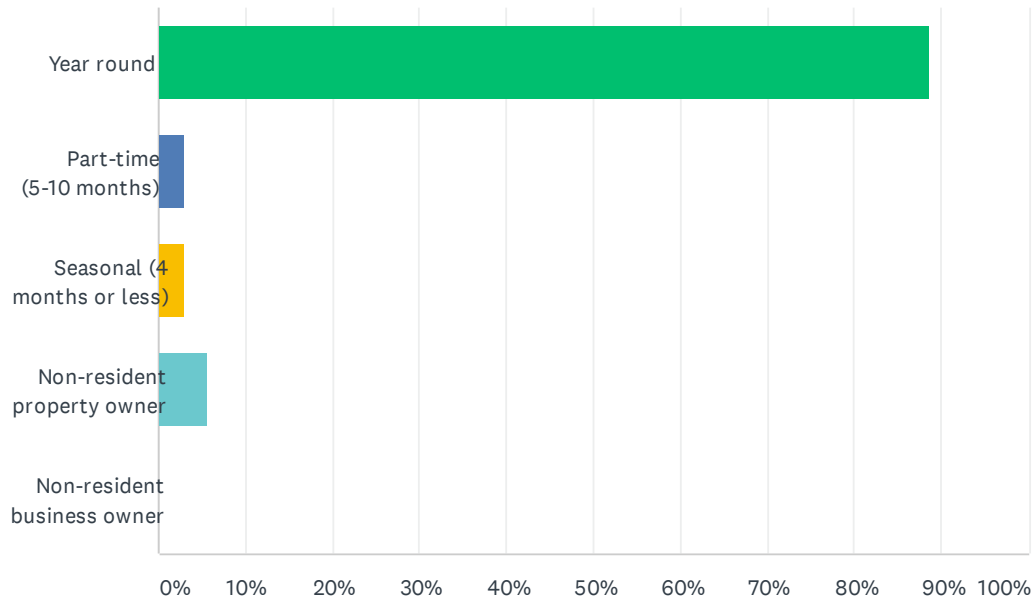


Q1 Which option best describes your residency status in Brownfield?

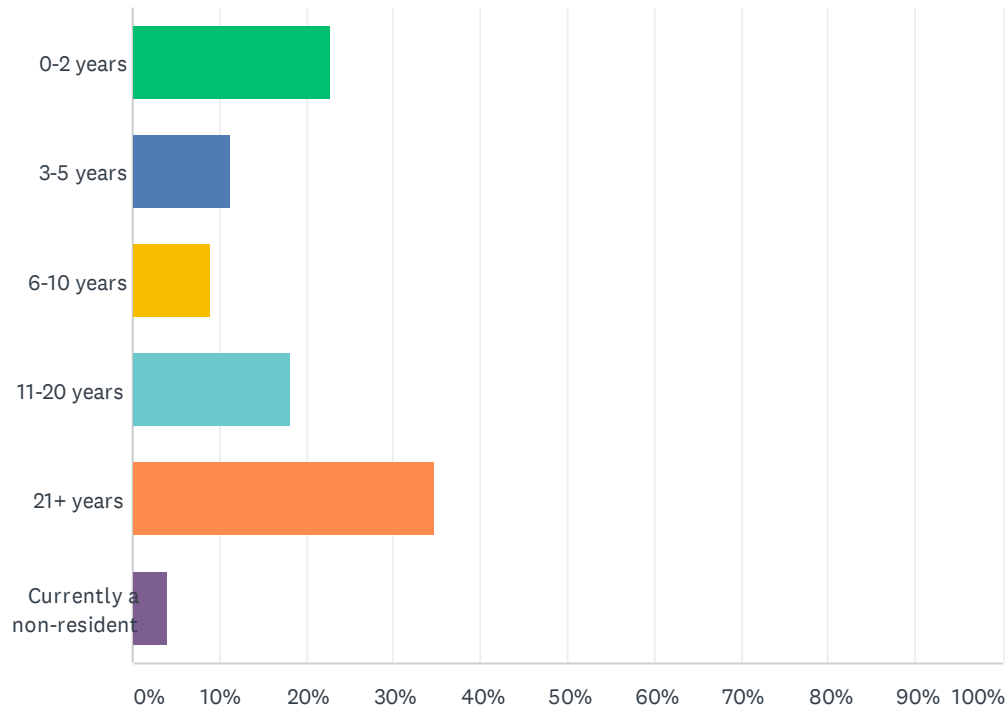

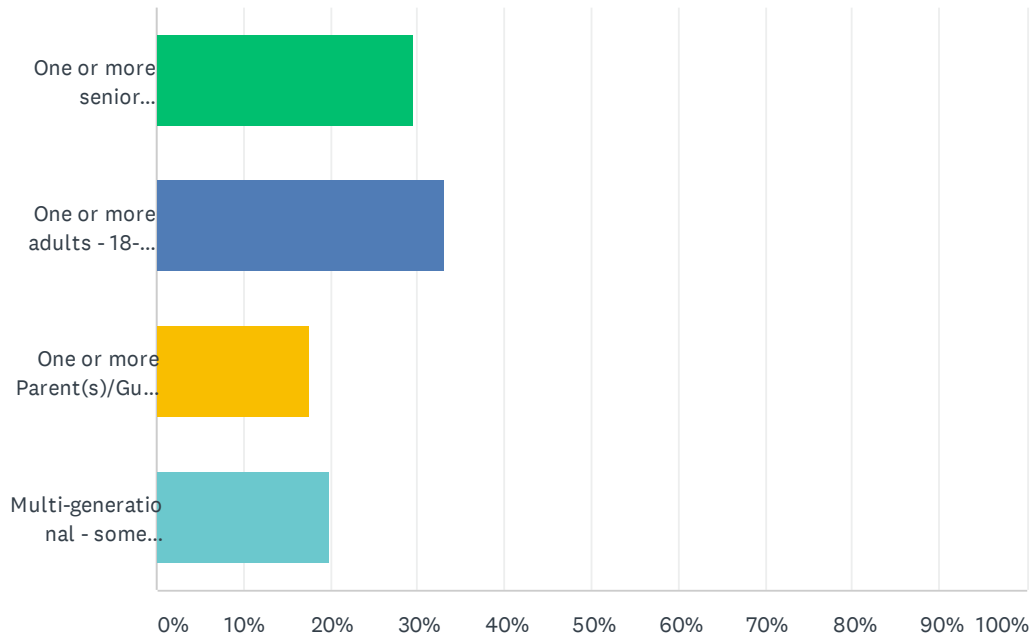

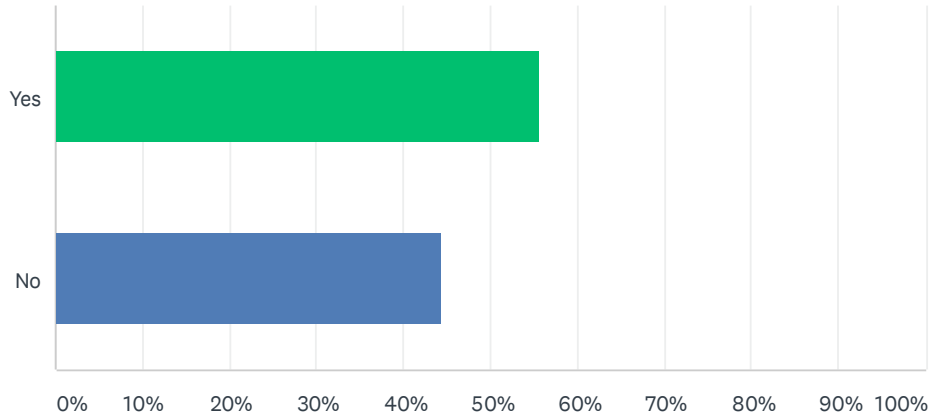

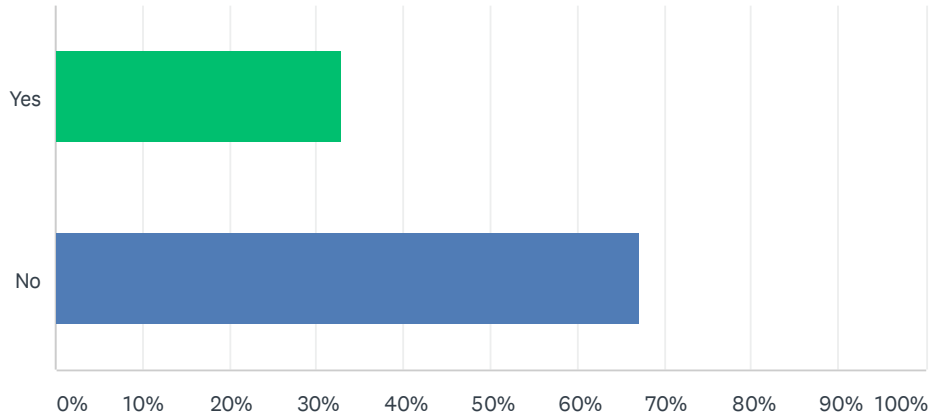

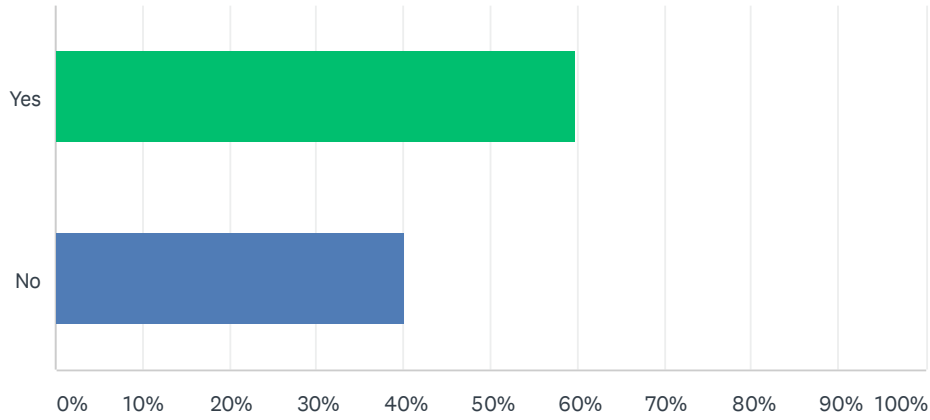

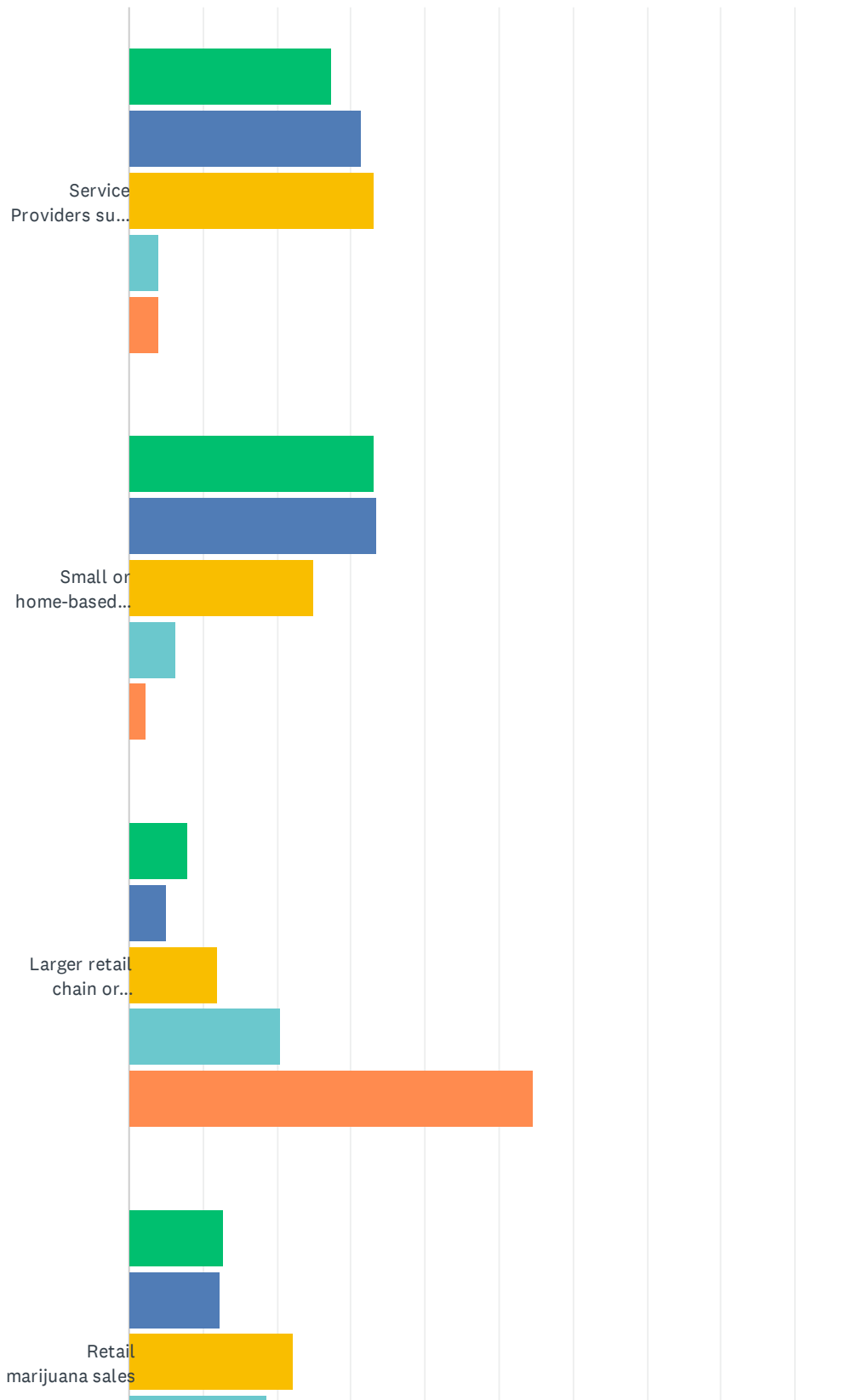

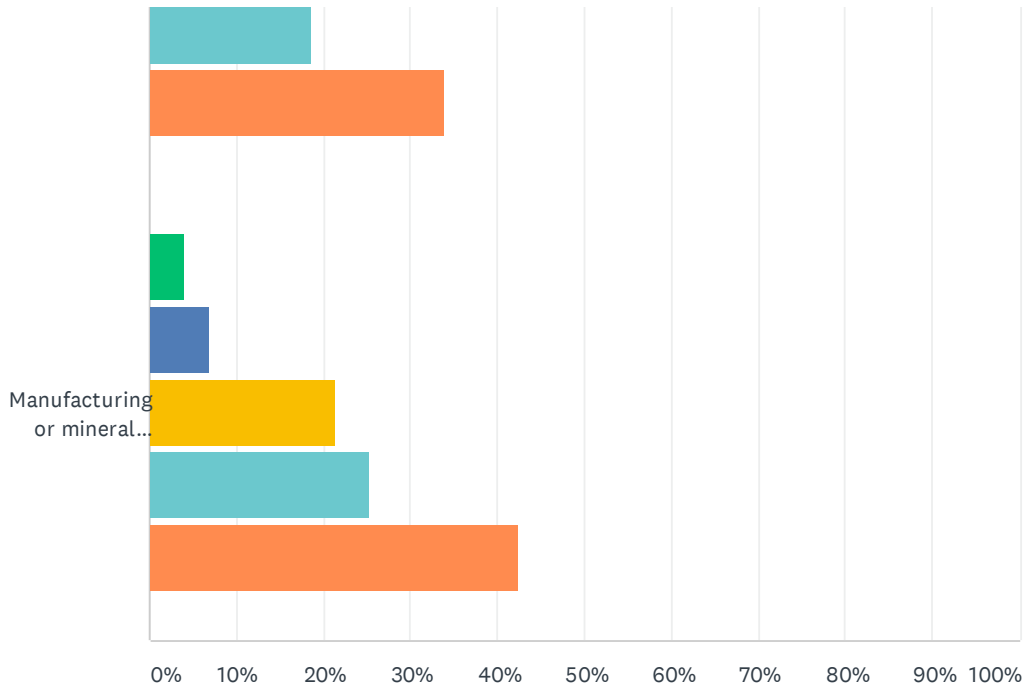

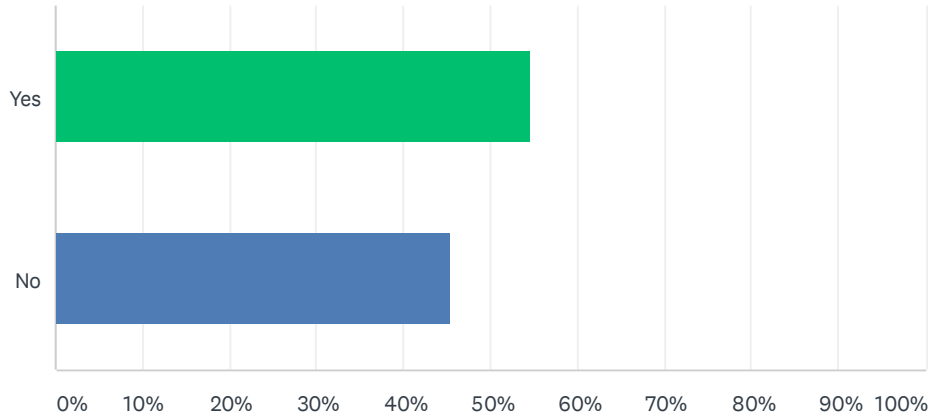

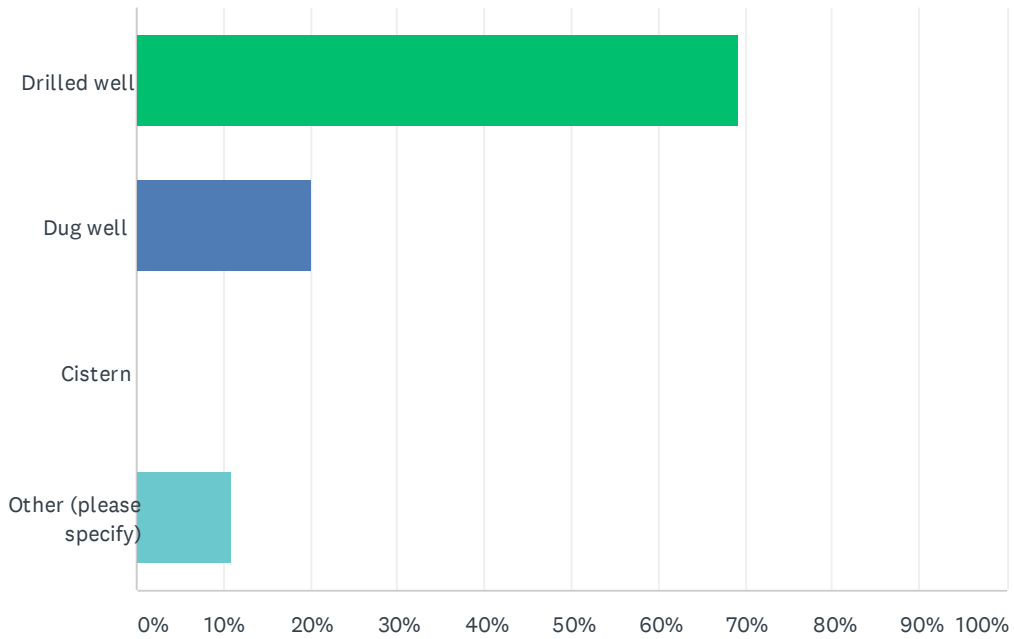

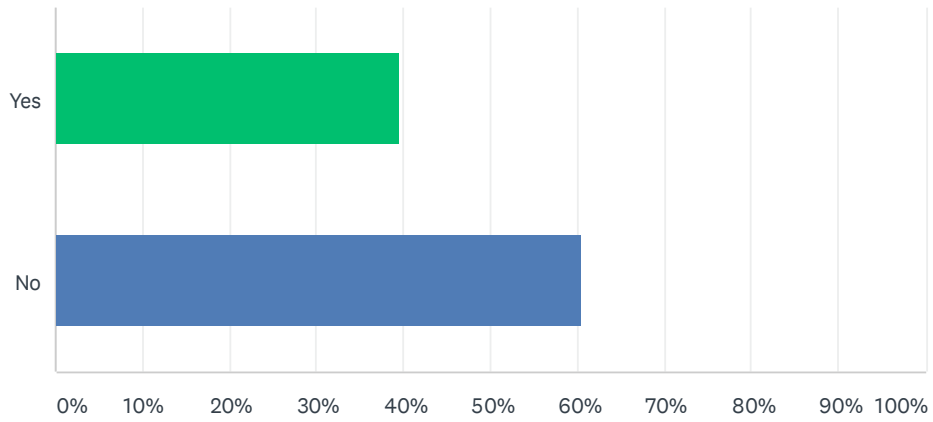

Q10 In the last 3 years have you had your drinking water tested?

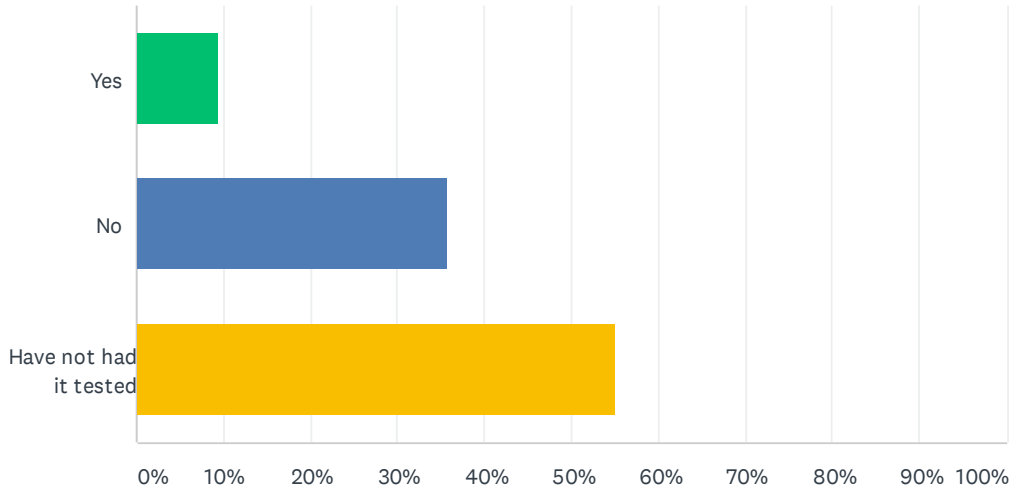

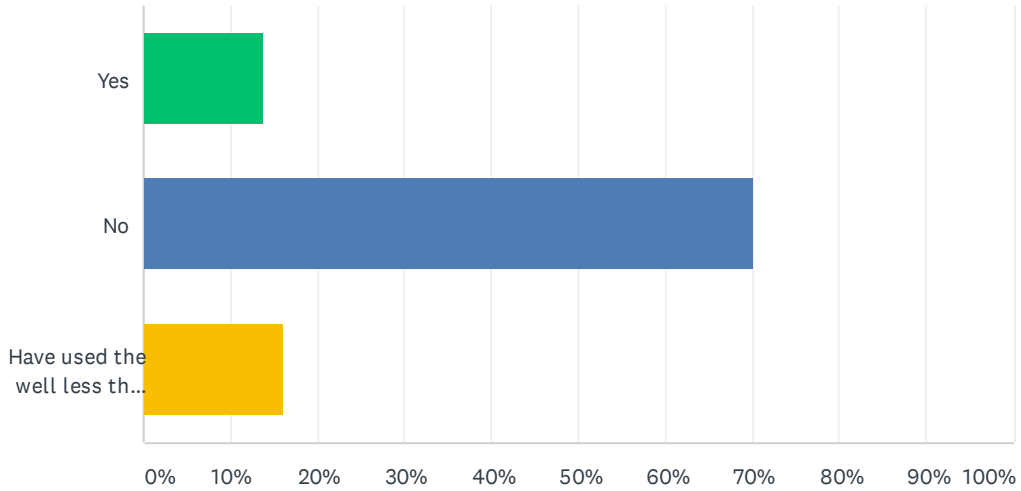

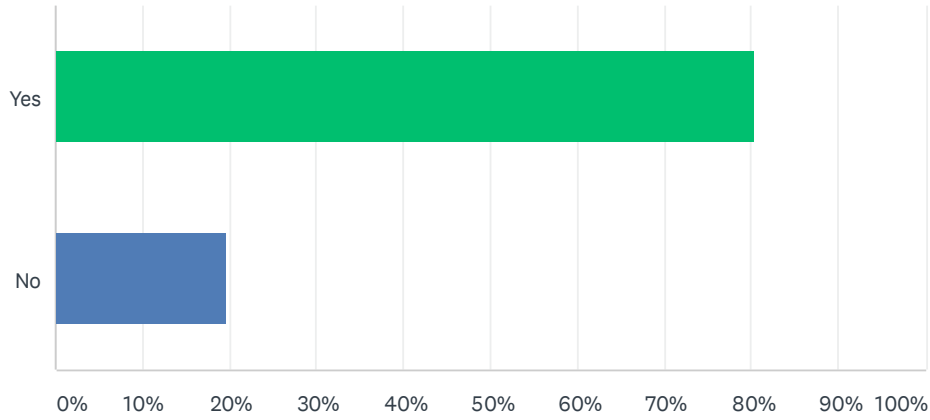
