### TOWN OF BROWNFIELD TRANSFER STATION PERMIT ORDINANCE

Approved May 8, 2000 by the Board of Selectmen Effective May 8, 2000

AN ORDINANCE REGULATING ACCESS TO THE TRANSFER STATION BY RESIDENTS AND TAXPAYERS ONLY OF THE TOWN OF BROWNFIELD AND REPEALING ALL OTHER ORDINANCES AND SECTIONS OF ORDINANCES IN CONFLICT HEREWITH.

Be it enacted by the Board of Selectmen for the Town of Brownfield as Follows:

# **SECTION 1-Admission into the Transfer Station**

No person shall enter the Transfer Station without a Transfer Station permit sticker affixed to his or her vehicle on the windshield or rear window.

Transfer Station permit stickers will only be issued to residents or taxpayers of the Town of Brownfield.

## **SECTION 2-General Penalty**

Unless another penalty is expressly provided by State Law, any person guilty of a violation of any provision of this Ordinance shall be refused entry into the Transfer Station.

Any person violating any provision of this Ordinance shall be subject to the general penalty imposed for violation of this Ordinance.

## **SECTION 3-Subsequent Penalty**

After one violation if the person tries to obtain entry again into the Transfer Station while still in violation of any provision of this Ordinance, the second offense penalty will apply. The person may be required to pay the "Second Offense" payment to avoid prosecution in District Court.

The penalty for second and subsequent offenses shall be \$10.00. Such payment shall in no event be construed as an enforced imposition of a fine or penalty, but on the other hand shall be construed to be an amount which an offender may voluntarily contribute towards the cost and expense of furnishing to the public a less expensive alternative method of regulating and administering Transfer Station permit sticker violations.

#### **SECTION 4-Validity**

If any part or parts of this Ordinance are for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance.

### **SECTION 5-Former Transfer Station Permit Ordinances Repealed**

All former Transfer Station permit ordinances of this Town are hereby repealed except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed prior to the enactment of this Ordinance.

#### **SECTOIN 6-Certification and Public Notice**

The Town Clerk shall certify to the passage of this Ordinance and cause notice of same to be published in the Bridgton News and the Shopping Guide.

#### **SECTION 7-Effective Date**

This Ordinance shall take effect on May 8, 2000.
